



PRIVACY POLICY

This Privacy Policy applies to the personal data you provide to Europair Broker S.A. (hereinafter 'Europair') through the website <http://www.europair.com> (hereinafter, 'the Platform' or 'the Website', both terms used interchangeably throughout this text). What information might we access to and for what purposes?

1. Membership

Its purpose is to fulfil your application, create your User account and ensure a mean of contact.

4. Mobile App

The Mobile App of Europair, "Europair Jet", includes the forms necessary to request the budget, which would be necessary to include, at least, the name, email and cell number. Europair may use such information to obtain a way of contact with the user and in order to send the budget.

Depending on how are configured the options for geolocalisation of your device, Europair may have access to the information related with your location when using the App. Europair will use such information with the sole purpose of personalize and provide the Services. At any moment, trough your device, you can modify the options for geolocalisation.

5. Cookies

Europair uses technologies that allow us to get information about your browsing activity and preferences. For that purpose, we use little files, called *cookies*, that we install in your terminal equipment. Please check our [Cookie Policy](#) for further information.
